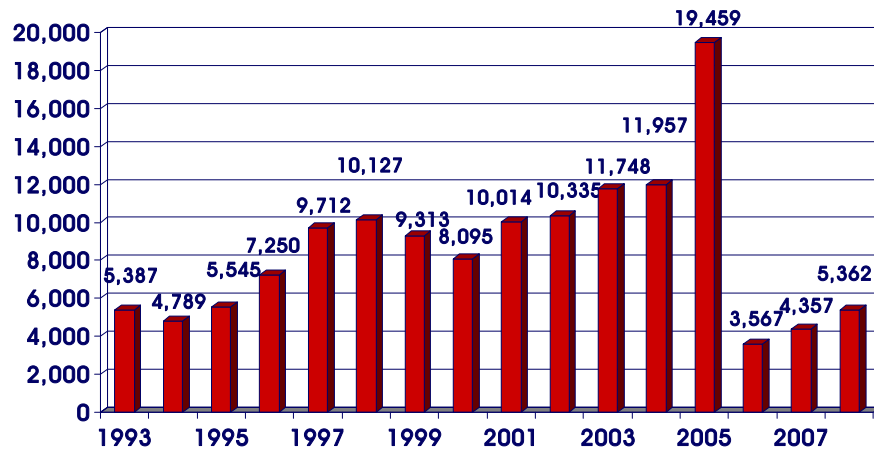

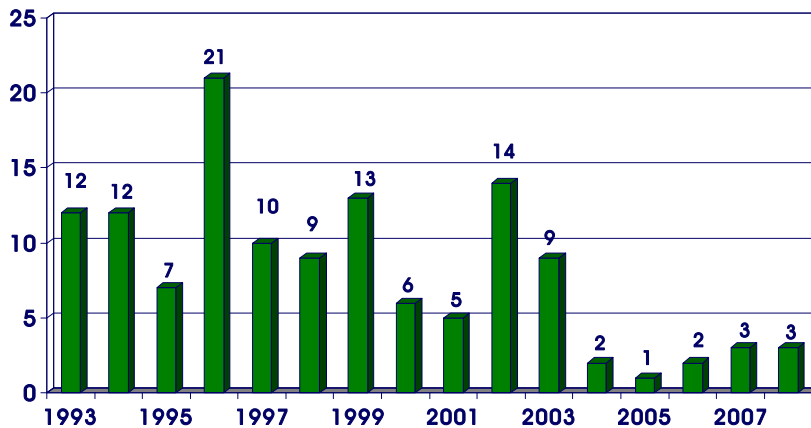

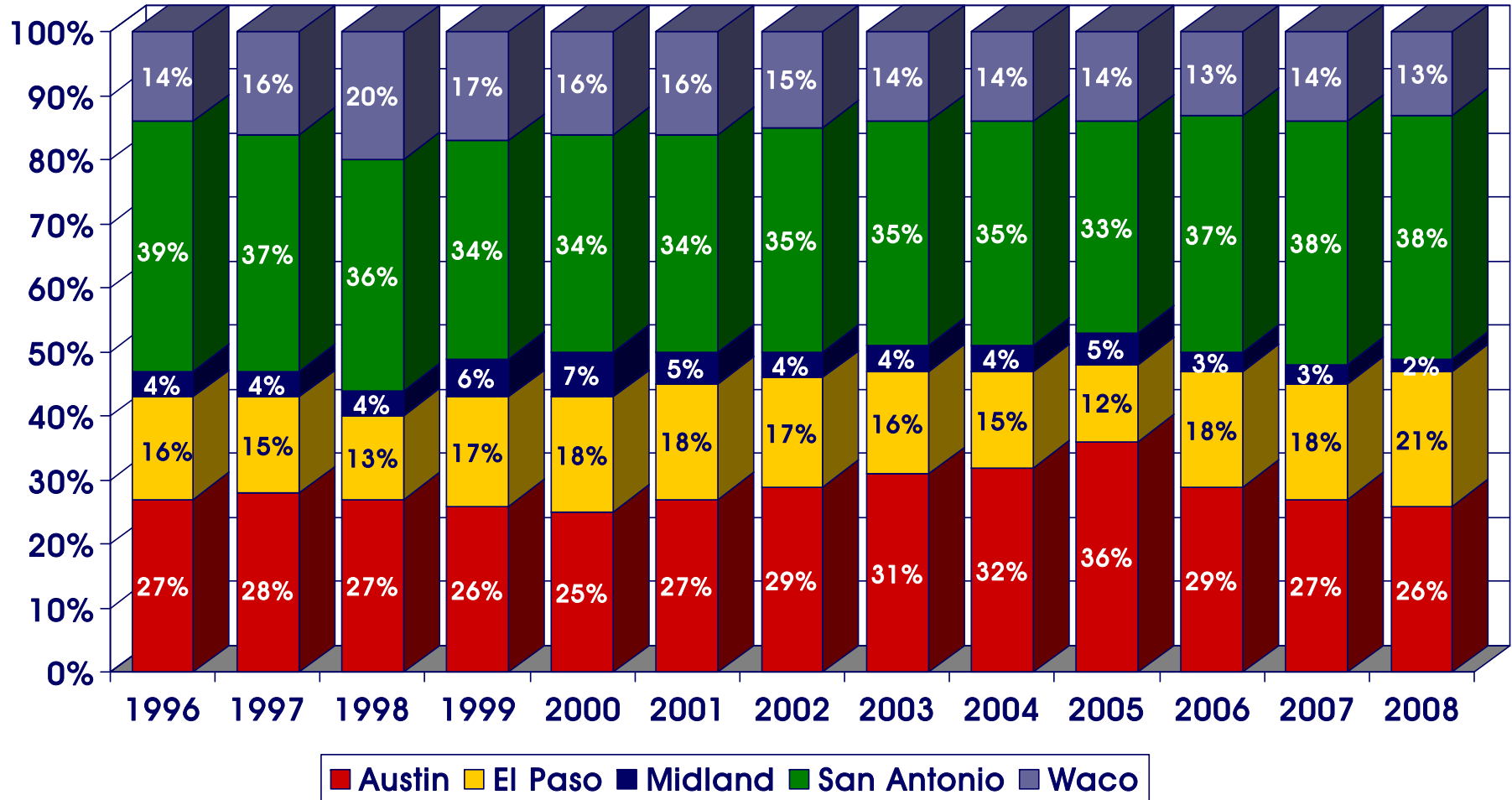

Note: Total filings include both Bankruptcy and Adversary cases.



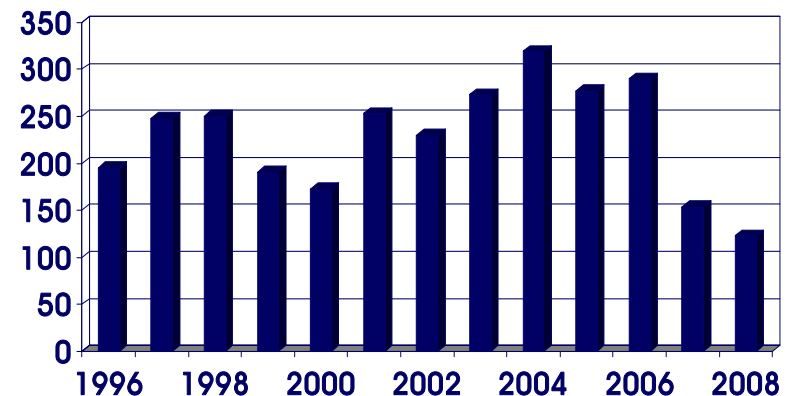
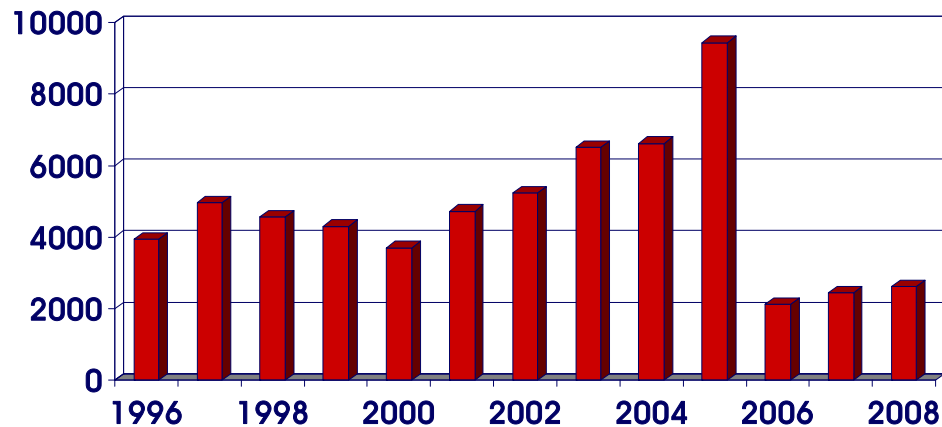
